CITIZENSHIP OF SEYCHELLES ACT, 1976

(Act 9 of 1976)

Citizenship of Seychelles (Amendment) Regulations, 1983

In exercise of the powers conferred by section 18 of the Citizenship of Seychelles Act, 1976, the Minister hereby makes the following Regulations —

1. These Regulations may be cited as the Citizenship of Seychelles (Amendment) Regulations, 1983.

2. In the Citizenship of Seychelles Regulations, 1976 (in these Regulations referred to as "the Principal Regulations") after Regulation 11 there is inserted —

"Application 11A. An application for a certificate of registration under section 12(3) of the Constitution shall be made on a Form IMM7B as set out in the First Schedule."

3. In the Principal Regulations there is inserted after Regulation 12 —

"Certificate 12A. A certificate of registration granted by the Minister shall be in the form set out as Registration Form IMM8A of the First Schedule."

4.(1) The First Schedule to the Principal Regulations is amended as follows —

(a) in Part III (Certificate of Sponsors) of Form IMM7 (Application for naturalisation as a Citizen of Seychelles) there shall be inserted after the word "Assembly" the words ", a Chairman of a Branch of the Seychelles People's Progressive Front"; and

(b) in Part II (Certificate of sponsors) of the Form IMM7A (Application for naturalisation as a citizen of

Seychelles by a person married to a citizen of Seychelles) the words "Member of the Central Executive Committee" shall be omitted and there shall be substituted therefor the words "Chairman of a Branch";

- (c) after Form IMM7A there is inserted the form shown in the Schedule to these Regulations as Form IMM7B; (d) for Form IMM8 there is substituted the forms shown in the Schedule to these Regulations as Form IMM8 and Form IMM8A.

(2) The Second Schedule to the Principal Regulations is revoked and there is substituted therefor —

(a) under section 7 of the Citizenship of Seychelles Act, 1976;	15,000

(b) under section 14(1) or (2) of the Constitution	15,000
4. Registration of renunciation of Seychelles citizenship	500
5. Registration of renunciation of foreign citizenship	200
6. For each copy certificate of registration or naturalisation	150
7. For the administration and attestation of the oath or a declaration etc. by a magistrate or notary (maximum fee)	25 "
